Infant, toddler, pre-school and school-age children up to age 12 make up 19% of the total population in Forsyth county (361,444). Large percentages (55%) of children under 6 years of age live in households with only one working parent. 45% live in single parent households.

The median household income in Forsyth county is \$46,912. This is a 0.7% increase from the median household income for the state of North Carolina (\$46,549) and a 10.9% decrease from the nation's (\$52,029) median household income.

The poverty rate for Forsyth County was 16.5% in 2009, while the state of North Carolina's rate was 16.2% compared to 14.3% for the Nation. 26.4% of Forsyth County's children under the age of 6 live in poverty.

In July of 2010 the unemployment rate for Forsyth County was 9.5% compared to 10% for the state of North Carolina and 9.7% for the United States.







### QUALITY OF CHILD CARE

The quality of a child care program sets the stage for successful early learning and life-long achievements.

The Division of Child Development, North Carolina's regulatory agency for child care, created the Five Star Rated Licensing System as a tool to assist families and individuals with identifying quality child care.

A one star license indicates a child care program meets North Carolina's minimum standards to be licensed.

Two to five star licenses indicate a program has been evaluated for, and met, higher standards.

### **Definitions:**

**Child Care Center** - independently operated or operate in schools, workplaces, individual homes (considered small centers), churches or synagogues. Most operate on a fixed schedule, eight or more hours per day, Monday through Friday. Children in centers are usually grouped by age. All centers must meet state regulations for the legal operation of a child care facility.

**Family Child Care Home (FCCH)** - operated by individuals who provide care in their homes for more than two children who are not related to them. These programs offer a home-like setting that provides the opportunity for siblings to stay together. All FCCH must meet state regulations for the legal operation of a child care facility.

**GS110-106** - operated by a church, synagogue, or school of religious charter. While exempt from licensure, they must file a notice of intent to operate a child care facility with the state.

**Head Start** - offers comprehensive child development services to both economically disadvantaged and at risk three and four year old children, with a special focus on helping preschoolers develop early reading and math skills.

**More at Four** - a state-funded pre-kindergarten program that is narrowly targeted to at-risk four-year-olds. Its purpose is to provide an academic pre-kindergarten experience targeting at-risk children from low-income families who have not been served in any other formal program.

**Preschool Program** - operate for four hours or less per day serving children between the ages of 0-5 years. They typically operate on the same calendar year as the public school system. These programs are exempt from following state licensing guidelines.

**School-age Program** – serves school-age children and operate before and/or after school hours, during school holidays and vacations. Family child care homes, child care centers and schools typically offer this type of care. Programs that operate for four hours or less per day are exempt from following state licensing guidelines.

**Summer Camp** - generally designed for school-age children and operate during he day for less than four months. They may be offered by child care centers colleges, recreation sites, faith-based groups, or other sponsoring organizations. This type of program is exempt from state licensure.
