Contest Rules

4. Contest Period

The Contest begins on October 01, 2020 at 1pm Eastern Standard Time and ends on October 29, 2020 at 5pm Eastern Standard Time (the "Contest Period"). 5. How to Enter

Online: This method of entry will be available by visiting our website at <u>www.childcareresourcecenter.org</u> or the event site at https://ccrccostumecontest.causevox.com/ and following the directions provided to fill out the entry information, and submit.

Limit one (1) entry per email for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.

6. Prize Drawing

On or about October 31, 2020, the Sponsor will select potential winners based on the entries receiving the highest fundraising amounts. Raffle items will be selected randomly from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about November 02, 2020. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize.
